INTERNAL RULES AND REGULATIONS OF THE MONTFERRAT BEACH

Foreword

The Détente et Clapotis Beach beach has been adapted to provide comfort and safety to its users.

Despite the presence of qualified personnel, the behaviour of each person remains essential to the smooth running of the whole. Hygiene, but more importantly security, is everyone's business.

Parents and accompanying adults, be vigilant, the beach is not a day-care, do not let your young children alone. The rules of the beach are valid for all so that everyone can find what they seek, relaxation, recreation or sport, in the best conditions.

Rules of the Beach of the Véronnière Commune of Monferrat.

Art. 1 - OPENING

The opening period and the opening hours of the beach are posted for public knowledge. The campsite reserves the right to change the schedule and rules of the beach or close it down, particularly for reasons of hygiene, safety or for technical reasons.

Art. 2 - CONDITIONS OF ACCESS AND EXIT

Anyone wishing to enter the beach grounds must pay an entry fee. The entrance will be done only by the access created for the purpose next to the reception building and no one is allowed to enter the beach by any other access. Besides the campers who have free access to the beach and must wear a bracelet, <u>swimming in the lake is not allowed outside the supervised hours and forbidden outside the opening periods</u>.

Anyone inebriated or under the influence of drugs will be denied access to the beach or may be excluded from the place.

Art. 3 - HYGIENE

To ensure the cleanliness of the water it is forbidden for dogs or any other domestic animals to bathe in the lake.

Art.4 - DUTY OF SAFETY FOR USERS

- Swimming is strictly regulated: it is only allowed inside the security perimeter and delimited by buoys. It is strictly forbidden outside supervised periods.

Beach access will be denied to anyone:

- appearing inebriated, incorrectly dressed or if the lifeguards or other users have already had to complain about,
- with animals,
- unaccompanied children under 13 years old.
- to canoes, kayaks, boards, boats or other craft that would not have the express permission of the management...

It is strictly forbidden:

- to push or jump into the water,
- to throw rocks,
- to pretend to drown.

In addition, it is also forbidden:

- to touch the different rescue or cleanup equipment,
- to move the bathing limitation lines and panels,
- to go into technical and admin offices without being invited.

In case of accident immediately inform the lifeguards who will take all necessary measures.

The management is not responsible for any accidents due to the non conformity to the present regulation.

Art. 5 - DRESS CODE AND FACILITY APPEARENCE

Children under 13 years old must be accompanied by an adult while on the beach.

The introduction and consumption of alcohol as well as that of radios, CD players and other audio devices in the perimeter of the beach is prohibited.

The dress code of beach goers, their attitude towards others and towards the staff must meet the expected decorum and decency in the interest of all.

Every person must refrain from any action that could affect the cleanliness, hygiene and appearance of the beach.

It is therefore strictly forbidden to:

- bring glass containers or objects,
- have picnics,
- to throw papers and empty packages on the beach or in the water
- to use soap on the beach,
- to go to the beach in case you have a skin condition, plantar warts or a wound covered with bandages.

Anyone who enters the beach enclosure adheres unconditionally to this regulation.

Art. 6 - BARBEQUE

Barbeques are forbidden.

For reasons of security and respect towards other people, no kinds of barbeque or ground fires are allowed on the Détente et Clapotis beach.

Art 7 - CONDITIONS OF ACCESS FOR GROUPS

The groups (lsh, clsh, cvl) have to be the object of a statement to the Direction Départementale de la Jeunesse et des Sports and have to conform to the current specific legislation (decree of the 30th june 2003 released at the J.O. of the 04/07/2003).

To be allowed to access the Detente et Calpotis beach, they have to make a reservation before the arriving day or to ask for the lifeguard's agreement or to the reception. It will be mandatory for the groups to fill the « groups » form before they access the beach (names of the persons in charge. of the supervisors and of the accompanied persons + ddjs declaration). Futhermore, the extract from article 8 has to be initialled for each group. Ask for the lifeguard's agreement and instructions before swimming, regarded to the number of people in the supervised swimming area. For safety purposes, one group will be admitted in the water per holiday center (8 children for one supervisor for the 6 years old and more or 5 children for one supervisor for the under 6).

Art. 8 - FACILITIES PROTECTION

It is forbidden to damage the campsite facilities. All damage will be fixed by the owner of the campsite but at the expense of the person or persons who did the damage without prejudice of criminal prosecution.

Art. 9 - NON RESPECT OF THE REGULATION

Anyone entering the beach area automatically accepts, without reserve, the present regulation. The management isn't in any case responsible for accidents and damage resulting, directly or indirectly from failure to observe the provisions of this regulation.

Art. 10 - COMPLAINTS
